

## **STAR 102.5'S CHRISTMAS WISH 2024**

Star 102.5's "Christmas Wish" is an annual contest that happens in three phases. The online nomination phase will take place from midnight on Monday October 28<sup>th</sup> through 11:59 PM on Friday December 13<sup>th</sup>. The week of November 25<sup>th</sup>, the discussion phase begins. The final phase is the awarding phase where our on-air Star 102.5 staff will notify the nominee(s) that their wish will be granted, which will take place between December 2<sup>nd</sup> and December 20<sup>th</sup>. In this contest, the "prize" in question is having the wish granted. The value of the granted wish or wishes may not exceed \$7500.

To submit a Christmas Wish to be granted, listeners must go to [www.star1025.com](http://www.star1025.com) and complete the digital nomination form. If a listener does not have internet access, they may also mail their nomination to the Des Moines Radio Group office at 1416 Locust St. Des Moines, Iowa 50309. A listener may submit a wish on behalf of someone else, or themselves. Once the submissions close, the on-air STAR 102.5 KSTZ-FM staff will review the entries and bring them before a committee made up of Des Moines Radio Group employees, which will meet at least once per week to choose which of the Christmas Wishes to "grant". The committee could grant anywhere between one to all submitted wishes, depending on the committee's budget and the feasibility of the wish/wishes. Once the committee has chosen the wish/wishes to fulfill, the nominee/nominees will be notified by the on-air staff and will be deemed the winner/winners of the contest. The nominees who do not have their wishes granted will not receive any correspondence from the committee, nor the on-air staff.

Listeners may submit multiple entries for this contest on behalf of another individual, but they may only submit one entry per individual. For example, if a listener submits one wish on behalf of their spouse, they may not submit an additional wish for their spouse. In the event of a dispute over an entry, the authorized account holder of the email address used to complete the registration form will be deemed the entrant, and that person must be eligible to win under these official rules. Submitting a wish does not guarantee it will be granted. STAR 102.5 KSTZ-FM has the final say as to who wins their contests.

By entering this contest, listeners understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. In certain circumstances, STAR 102.5 KSTZ-FM may share that Personal Data with sponsors, advertisers, affiliates, or other partners. This contest is open to all eligible Iowa residents 18 years or older. For Christmas Wish only, anyone may enter regardless of when they last won on STAR 102.5. Employees of STAR 102.5, the Des Moines Radio Group, and its ultimate parent company, Saga Communications, Inc., their advertising agencies, affiliates, contest sponsors, employees and immediate families of each, and employees of all media of mass communication within a one-hundred-mile radius of the STAR 102.5 main studio are not eligible to win any contest. Immediate family includes the spouse, great-grandparents, grandparents, parents, brothers, sisters, children, grandchildren, and great-grandchildren of the employee and his/her spouse. This also includes individuals for whom the employee is current legal guardian.

*These are the rules governing all contests aired on STAR 102.5 KSTZ-FM radio and on the STAR 102.5 website, unless otherwise specified. In the following rules, "STAR 102.5 KSTZ-FM" means Saga Communications of Iowa, LLC, dba Des Moines Radio Group and its parent corporation, Saga Communications, Inc., which owns STAR 102.5 KSTZ-FM radio:*

1. No purchase is necessary to enter any STAR 102.5 KSTZ-FM contest.
2. To be eligible to win any prize on STAR 102.5 KSTZ-FM you must not have won anything on STAR 102.5 KSTZ-FM in the past 14 days or any prize valued at \$600 or more in the past 6 months. Only one winner per household is permitted within 30 days after a household has a winner. Any prize awarded to an ineligible listener will be deemed null and void, and an alternate eligible winner may be named.
3. Anytime you call the STAR 102.5 KSTZ-FM studios you assume that your call will be broadcast or recorded and you grant us permission to broadcast the call or record it for later broadcast.

  - E. Due to the nature of our programs that are heard on-line over the internet, contests may not be heard at all on STAR 102.5 KSTZ-FM. Contests heard on the radio station's internet audio stream may be slightly delayed from the time the contests are heard on the broadcast station, and will be running behind the broadcast signal. Thus, all contests heard on the internet are delayed. This delay can last for as much as 30 seconds or more. This means that when STAR 102.5 KSTZ-FM contests are played that require a specific caller to telephone the radio station (such as "Caller number 9 when you hear the sound effect"), listeners to the on-line audio stream may be at a disadvantage in participating over those listeners who hear the contests on-air.
