## STAR 102.5's Secret Sounds of Summer

Starting on Monday, June 9<sup>th</sup> and going through Friday, July 18<sup>th</sup>, STAR 102.5 will hold an on-air contest every weekday in which listeners have the opportunity to win a cash prize with STAR 102.5's Secret Sounds of Summer.

The object of "Secret Sounds of Summer" is to guess the specific sound being played over the air. Listeners must be as specific as possible to win the sound's cash prize i.e., "The buzzing of the fluorescent lights at Wells Fargo Arena," not just "Fluorescent lights." Every time a listener doesn't guess correctly, the cash prize for that sound will increase by \$102. Once a listener guesses the correct sound from the clip, the cash prize resets to the starting point of \$102. Listeners must listen for the cue to call and call into STAR studios at 515-280-1025 for the chance to guess the sound and win the prize.

Listeners may only win once, and only one win is permitted per household. Any attempt made by a listener to win multiple times, including by using someone else's personal information, will disqualify them. The use of software or hardware that allows a user to enter more than once is strictly prohibited in all Des Moines Media Group contests. In the event of a dispute over an entry, the authorized user of the email address given at the time of winning will be declared the entrant, and that person must be eligible to win under these official rules. These passes may be picked up at the Des Moines Media Group offices at 1416 Locust Street in Des Moines, Iowa. STAR 102.5 will not be held responsible if any events are cancelled, or prizes cannot be redeemed, due to circumstances outside of the station's control.
