

STAR 102.5's Secret Sounds of Summer

Starting on Monday, June 9th and going through Friday, July 18th, STAR 102.5 will hold an on-air contest every weekday in which listeners have the opportunity to win a cash prize with STAR 102.5's Secret Sounds of Summer.

The object of "Secret Sounds of Summer" is to guess the specific sound being played over the air. Listeners must be as specific as possible to win the sound's cash prize i.e., "The buzzing of the fluorescent lights at Wells Fargo Arena," not just "Fluorescent lights." Every time a listener doesn't guess correctly, the cash prize for that sound will increase by \$102. Once a listener guesses the correct sound from the clip, the cash prize resets to the starting point of \$102. Listeners must listen for the cue to call and call into STAR studios at 515-280-1025 for the chance to guess the sound and win the prize.

Listeners may only win once, and only one win is permitted per household. Any attempt made by a listener to win multiple times, including by using someone else's personal information, will disqualify them. The use of software or hardware that allows a user to enter more than once is strictly prohibited in all Des Moines Media Group contests. In the event of a dispute over an entry, the authorized user of the email address given at the time of winning will be declared the entrant, and that person must be eligible to win under these official rules. STAR 102.5 KSTZ-FM has the final say on who wins their contests.

By entering this contest, listeners understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. In certain circumstances, STAR 102.5 KSTZ-FM may share that Personal Data with sponsors, advertisers, affiliates, or other partners. These passes may be picked up at the Des Moines Media Group offices at 1416 Locust Street in Des Moines, Iowa. STAR 102.5 will not be held responsible if any events are cancelled, or prizes cannot be redeemed, due to circumstances outside of the station's control. Winners are expected to follow all COVID-19 protocols, or any other rules and restrictions put in place by the event organizers and venue. STAR 102.5 will make every reasonable effort to award prizes before any expiration dates or showtimes.

This contest is open to all eligible Iowa residents 18 or older who have not won anything on STAR 102.5, nor any [Des Moines Media Group station](#) within 30 days. That period extends to 6 months for those who have won prizes valued at \$600 or more. No purchase necessary. Prizes are not transferable, nor can they be substituted for cash or an alternative prize. Winners must present a valid state ID and w9 to collect the prize.

Winners are also responsible for any local, state, or federal taxes and fees associated with the prize. This prize will be worth between \$102 and \$9,180.

Employees of KSTZ, the Des Moines Media Group, Saga Communications of Iowa, LLC, and its ultimate parent company, Saga Communications, Inc., their advertising agencies, affiliates, contest sponsors, employees and immediate families of each, and employees of all media of mass communication within a one-hundred-mile radius of the KSTZ main studio are not eligible to win any contest. "Immediate family" includes the spouse, great-grandparents, grandparents, parents, brothers, sisters, children, grandchildren, and great-grandchildren of the employee and his/her spouse. *These are the rules governing all contests aired on STAR 102.5 KSTZ-FM radio and on the star1025.com website, unless otherwise specified. **In the following rules, "STAR 102.5 KSTZ-FM" means Saga Communications of Iowa, LLC, dba Des Moines Media Group and its parent corporation, Saga Communications, Inc., which owns STAR 102.5 KSTZ-FM radio:***

1. No purchase is necessary to enter any STAR 102.5 KSTZ-FM contest.
2. To be eligible to win any prize on STAR 102.5 KSTZ-FM you must not have won anything on STAR 102.5 KSTZ-FM in the past 30 days or any prize valued at \$600 or more in the past 6 months. Only one winner per household is permitted within 30 days after a household has a winner. Any prize awarded to an ineligible listener will be deemed null and void, and an alternate eligible winner may be named.
3. Anytime you call the STAR 102.5 KSTZ-FM studios you assume that your call will be broadcast or recorded, and you grant us permission to broadcast the call or record it for later broadcast.

All winners of a prize valued at \$600 or more will be required to complete the appropriate tax forms at the STAR 102.5 KSTZ-FM studios prior to claiming prize. All winners will be sent a 1099 MISC federal tax form if in one calendar year the prize value of all prizes won exceeds \$600.
