

STAR APP SWEEPSTAKES – Cookies on Tap

“STAR 102.5’s App Sweepstakes: Cookies on Tap” is an app-exclusive, online contest where listeners have the chance to win a pair of tickets to the Girl Scouts 9th Annual Cookies on Tap Event at the Iowa Taproom on Thursday, October 9th. Must be 21 or older to attend the event.

To enter, listeners must download the STAR App before the app push goes out on Friday, September 26th at Noon and will have until Sunday, September 28th at 11:59 pm to submit their entry via a link on the STAR 102.5 app, directing them to a contest page where they must complete the entry form. Listeners can only enter once throughout the duration of the contest. All entries must be submitted by 11:59 PM on Sunday, September 28th to qualify. Five winners will be selected at random from the collected entries and contacted the following week of the contest.

Any attempt made by a listener to enter multiple times, including by using someone else’s personal information, will disqualify them. The use of software or hardware that allows a user to enter more than once per keyword is strictly prohibited. In the event of a dispute over an entry, the authorized user of the email address given at the time of winning will be declared the entrant, and that person must be eligible to win under these official rules. STAR 102.5 KSTZ-FM has the final say on who wins their contests.

These tickets will be treated as WILL CALL and can be picked up at the venue entrance on the day of the event. Winners must bring a valid photo ID to claim their tickets. STAR 102.5 is not responsible if tickets, certificates, or other prizes cannot be redeemed due to event cancellation, rescheduling, or circumstances beyond the station’s control. Winners are required to follow all venue and event organizer rules, including any current health and safety guidelines. The approximate retail value of these tickets is \$90
