

STAR TXT Sweepstakes: Arnolds Park Amusement Park

Starting Monday, December 15th, listeners can join the STAR Text Club by texting “STAR” to 515-280-1025. All members of the STAR Text Club will receive a message with a link to an online contest for a chance to win a four-pack of tickets to Arnolds Park Amusement Park that includes 4 Raceway Tickets & 4 Queen II Passes.

To participate, listeners must join the STAR Text Club before the text notification is sent out on Friday, December 19th at 11:00 am. Once they receive the text, members can follow the link to the contest page and complete the entry form. Entries must be submitted by Sunday, December 21st at 11:59 p.m. to qualify. The following week, one winner will be randomly selected from all eligible entries and contacted.

Listeners must have a working mobile phone with texting capabilities to enter this contest. Listeners can only enter once. Any attempt made by a listener to enter multiple times, including by using someone else’s personal information, will disqualify them. The use of software or hardware that allows a user to enter more than once per keyword is strictly prohibited. In the event of a dispute over an entry, the authorized user of the email address given at the time of winning will be declared the entrant, and that person must be eligible to win under these official rules. STAR 102.5 KSTZ-FM has the final say on who wins their contests.

By entering this contest, contestants understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. In certain circumstances, STAR 102.5 KSTZ-FM may share that Personal Data with sponsors, advertisers, affiliates, or other partners. These tickets are PHYSICAL and will need to be picked up at the station located at 1416 Locust St. in downtown Des Moines, right across from the Papa John Sculpture Park. We are open Monday through Friday, 8 am to 5 pm. STAR 102.5 will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station’s control. Winners are expected to follow all COVID-19 guidelines and any other rules and restrictions put forth by the event organizers and venue. These tickets have an approximate retail value of \$348.

This contest is open to all eligible Iowa residents 18 years or older who have not won anything on STAR 102.5, nor any Des Moines Media Group Station in the last 30 days.

This period extends to six months for those who have won any prize valued at \$600 or more. No purchase necessary. This prize has an approximate retail value of \$116. Prizes are non-transferable and cannot be exchanged, substituted or redeemed for cash.

Winners must present valid state ID and w9 to collect the prize. Winners are responsible for all taxes and fees associated with the prizes.

Employees of STAR 102.5, the Des Moines Media Group, and its ultimate parent company, Saga Communications, Inc., their advertising agencies, affiliates, contest sponsors, employees and immediate families of each, and employees of all media of mass communication within a one-hundred-mile radius of the STAR 102.5 main studio are not eligible to win any contest. “Immediate family” includes the spouse, great-grandparents, grandparents, parents, brothers, sisters, children, grandchildren, and great-grandchildren of the employee and his/her spouse. Any prize awarded to an ineligible listener will be deemed null and void, and an alternate eligible winner may be named.
