

## **STAR APP SWEEPSTAKES – Des Moines Home & Garden Show**

“STAR 102.5’s App Sweepstakes: Des Moines Home & Garden Show” is an app-exclusive, online contest where listeners have the chance to win a four-pack of tickets to the Des Moines Home & Garden Show at the Iowa Events Center, happening Thursday, February 12th through Sunday, February 15th. Tickets are valid for one single day of the event.

Plus, all winners will be entered into a grand prize drawing for a meet-and-greet for the winner and a guest with Craig Conover from *Southern Charm*.

To enter, listeners must download the free STAR 102.5 mobile app on their device and enter to win before the contest closes on Sunday. The contest officially opens on Friday, January 30<sup>th</sup> at 12:00 am and participants can submit their entry via a link on the STAR app, directing them to a contest page where they must complete the entry form. Listeners can only enter once throughout the duration of the contest. All entries must be submitted by 11:59 PM on Sunday, February 1<sup>st</sup> to qualify. Fifteen winners will be randomly selected from all eligible entries and contacted the following week. Five of those winners will also receive the grand prize meet-and-greet in addition to their tickets.

Any attempt made by a listener to enter multiple times, including by using someone else’s personal information, will disqualify them. The use of software or hardware that allows a user to enter more than once per keyword is strictly prohibited. In the event of a dispute over an entry, the authorized user of the email address given at the time of winning will be declared the entrant, and that person must be eligible to win under these official rules. STAR 102.5 KSTZ-FM has the final say on who wins their contests.

These tickets are DIGITAL and will be emailed to winners upon completion of a waiver during business hours, who must have a smartphone in order to use them at the venue. STAR 102.5 will make their best efforts to transfer tickets before the start of the event. STAR 102.5 will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station’s control. Winners are expected to follow all COVID-19 guidelines and any other rules and restrictions put forth by the event organizers and venue. These tickets have an approximate retail value of \$50.

**This contest is open to all eligible Iowa residents 18 years or older who have not won anything on STAR 102.5, nor any Des Moines Media Group Station in the last 30 days.**

This period extends to six months for those who have won any prize valued at \$600 or more. No purchase necessary. This prize has an approximate retail value of \$150. Prizes are non-transferable and cannot be exchanged, substituted or redeemed for cash. Winners must present valid state ID and w9 to collect the prize. 1. No purchase is necessary to enter any STAR 102.5 KSTZ-FM contest.
2. To be eligible to win any prize on STAR 102.5 KSTZ-FM you must not have won anything on STAR 102.5 KSTZ-FM in the past 30 days or any prize valued at \$600 or more in the past 6 months.
