

Hometown Throwdown: MICHAEL Theater Screening

“Ken and Tawinee’s Hometown Throwdown: MICHAEL Theater Screening” is an on-air contest held on STAR 102.5 that will occur from Monday, April 6th through Friday, April 10th between 7:00 AM and 10:00 AM. Ken & Tawinee will be giving five listeners the chance to win a four-pack of tickets to see MICHAEL at B&B Theatres in Ankeny on Saturday, April 25th—at a special 93.3 KIOA-exclusive screening! Admission to this special screening is limited, and tickets must be won through 93.3 KIOA or STAR 102.5.

This contest will feature two listeners who will play against each other to win the prize. To become the first contestant, a listener must hear the cue to call in to the KSTZ-FM studio at 515-280-1025 and be caller number ten. The second contestant will be Caller Eleven if they are not from the same city as Caller Ten. If Caller Eleven is from the same city as the first contestant, then the opportunity to play will move on to Caller Twelve, and so on, until the next caller is not from the same city as the first contestant. Once both contestants have been declared, the contest will begin.

The object of “Hometown Throwdown” is to be the first person to earn two points by correctly answering trivia questions on the air. Both contestants will be asked a question at the same time and must “buzz in” by yelling out the name of the city they are from. The first person to buzz in will have the opportunity to answer first and may only answer once per question. Contestants do not have to wait for the question to be read all the way through to buzz in, but if they interrupt the question, it will not be given in full again unless they answer incorrectly, and play moves on to the next contestant. For every correct answer, a contestant will earn one point. In the event both contestants buzz in at the same time, the on-air staff will choose who gets to answer first. There will be five winners in total for this contest, one per day.

Listeners may only enter once, and only one win is permitted per household. Any attempt made by a listener to win multiple times, including by using someone else’s personal information, will disqualify them. The use of software or hardware that allows a user to enter more than once is strictly prohibited in all Des Moines Media Group contests. In the event of a dispute over an entry, the authorized user of the email address given at the time of winning will be declared the entrant, and that person must be eligible to win under these official rules. STAR 102.5 KSTZ-FM has the final say on who wins their contests.

By entering this contest, listeners understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. In certain circumstances, STAR 102.5 KSTZ-FM may

These tickets will be handled as WILL CALL, and winners can check in at the event on the day of the screening to claim their seats. STAR 102.5 will make their best efforts to transfer tickets before the start of the event. STAR 102.5 will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station's control. Winners are expected to follow all COVID-19 guidelines and any other rules and restrictions put forth by the event organizers and venue. These tickets have an approximate retail value of \$85.

This contest is open to all eligible Iowa residents 18 or older who have not won anything on STAR 102.5, nor any Des Moines Media Group station within 30 days. That period extends to 6 months for those who have won prizes valued at \$600 or more. No purchase necessary. Prizes are not transferable, nor can they be substituted for cash or an alternative prize. Winners must present a valid state ID and w9 to collect the prize. Winners are also responsible for any local, state, or federal taxes and fees associated with the prize.

Employees of KSTZ, the Des Moines Media Group, Saga Communications of Iowa, LLC, and its ultimate parent company, Saga Communications, Inc., their advertising agencies, affiliates, contest sponsors, employees and immediate families of each, and employees of all media of mass communication within a one-hundred-mile radius of the KSTZ main studio are not eligible to win any contest. - No purchase is necessary to enter any STAR 102.5 KSTZ-FM contest.
- To be eligible to win any prize on STAR 102.5 KSTZ-FM you must not have won anything on STAR 102.5 KSTZ-FM in the past 30 days or any prize valued at \$600 or more in the past 6 months. Only one winner per household is permitted within 30 days after a household has a winner. Any prize awarded to an ineligible listener will be deemed null and void, and an alternate eligible winner may be named.
