

STAR 102.5's Secret Sounds of Summer

Starting on Monday, June 15th and going through Friday, July 10th, STAR 102.5 will hold an on-air contest every weekday in which listeners have the opportunity to win a cash prize with STAR 102.5's Secret Sounds of Summer, presented by Flooring America.

The object of "Secret Sounds of Summer" is to guess the specific sound being played over the air. Listeners must be as specific as possible to win the sound's cash prize i.e., "The buzzing of the fluorescent lights at Wells Fargo Arena," not just "Fluorescent lights." Every time a listener doesn't guess correctly, the cash prize for that sound will increase by \$102. Once a listener guesses the correct sound from the clip, the cash prize resets to the starting point of \$102. Listeners must listen for the cue to call and call into STAR studios at 515-280-1025 for the chance to guess the sound and win the prize. Participants can only win a jackpot once through the promotion.

An online second chance sweepstakes will be available through the Secret Sounds of Summer page on the STAR 102.5 app and at star1025.com. An additional sound will be posted on that page, and listeners can enter online to guess what the sound is. Each participant may submit one guess per day throughout the promotion period. The online second chance entry period runs from Monday, June 15 at 12:00 a.m. through Friday, July 10 at 11:59 p.m. The online second chance prize is \$500. Participants are not eligible if they have previously won a Secret Sounds of Summer jackpot during this year's promotion.

Listeners may only win once, and only one win is permitted per household. Any attempt made by a listener to win multiple times, including by using someone else's personal information, will disqualify them. The use of software or hardware that allows a user to enter more than once is strictly prohibited in all Des Moines Media Group contests. In the event of a dispute over an entry, the authorized user of the email address given at the time of winning will be declared the entrant, and that person must be eligible to win under these official rules. STAR 102.5 KSTZ-FM has the final say on who wins their contests.

By entering this contest, listeners understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. In certain circumstances, STAR 102.5 KSTZ-FM may share that Personal Data with sponsors, advertisers, affiliates, or other partners. These cash prizes must be picked up at the Des Moines Media Group offices at 1416 Locust Street in Des Moines, Iowa. STAR 102.5 will not be held responsible if any events

are cancelled, or prizes cannot be redeemed, due to circumstances outside of the station's control. Winners are expected to follow all COVID-19 protocols, or any other rules and restrictions put in place by the event organizers and venue. STAR 102.5 will make every reasonable effort to award prizes before any expiration dates or showtimes.

This contest is open to all eligible Iowa residents 18 or older who have not won anything on STAR 102.5, nor any [Des Moines Media Group station](#) within 30 days. That period extends to 6 months for those who have won prizes valued at \$600 or more. No purchase necessary. Prizes are not transferable, nor can they be substituted for cash or an alternative prize. Winners must present a valid state ID and w9 to collect the prize. Winners are also responsible for any local, state, or federal taxes and fees associated with the prize. This prize will be worth between \$102 and \$4,080.

Employees of KSTZ, the Des Moines Media Group, Saga Communications of Iowa, LLC, and its ultimate parent company, Saga Communications, Inc., their advertising agencies, affiliates, contest sponsors, employees and immediate families of each, and employees of all media of mass communication within a one-hundred-mile radius of the KSTZ main studio are not eligible to win any contest. 1. No purchase is necessary to enter any STAR 102.5 KSTZ-FM contest.
2. To be eligible to win any prize on STAR 102.5 KSTZ-FM you must not have won anything on STAR 102.5 KSTZ-FM in the past 30 days or any prize valued at \$600 or more in the past 6 months. Only one winner per household is permitted within 30 days after a household has a winner. Any prize awarded to an ineligible listener will be deemed null and void, and an alternate eligible winner may be named.
