

## STAR App Sweepstakes – Olivia Rodrigo New Album Giveaway

“STAR 102.5’s App Sweepstakes: Olivia Rodrigo New Album Giveaway” is an app-exclusive, online contest where listeners have the chance to win a vinyl copy of Olivia Rodrigo’s new album, *you seem pretty sad for a girl so in love*. One lucky grand prize winner will also receive Olivia Rodrigo’s complete vinyl catalog, including the new album.

To enter, listeners must download the free STAR 102.5 mobile app on their device and enter to win before the contest closes on Sunday. The contest officially opens on Friday, June 12<sup>th</sup> and participants can submit their entry via a link on the STAR app, directing them to a contest page where they must complete the entry form. Listeners can only enter once throughout the duration of the contest. All entries must be submitted by 11:59 PM on Sunday, June 14<sup>th</sup> to qualify. Four winners will be randomly selected from all eligible entries and contacted the following week.

Any attempt made by a listener to enter multiple times, including by using someone else’s personal information, will disqualify them. The use of software or hardware that allows a user to enter more than once per keyword is strictly prohibited. In the event of a dispute over an entry, the authorized user of the email address given at the time of winning will be declared the entrant, and that person must be eligible to win under these official rules. STAR 102.5 KSTZ-FM has the final say on who wins their contests.

This prize is PHYSICAL and will need to be picked up at the station located at 1416 Locust St. in downtown Des Moines, right across from the Pappajohn Sculpture Park. We are open Monday through Friday, 8 am to 5 pm. STAR 102.5 will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station’s control. Winners are expected to follow all COVID-19 guidelines and any other rules and restrictions put forth by the event organizers and venue. This prize has an approximate retail value of \$35 and \$110 for the grand prize.

**This contest is open to all eligible Iowa residents 18 years or older who have not won anything on STAR 102.5, nor any Des Moines Media Group Station in the last 30 days.**

are non-transferable and cannot be exchanged, substituted or redeemed for cash. Winners must present valid state ID and w9 to collect the prize. Winners are responsible for all taxes and fees associated with the prizes.

2. To be eligible to win any prize on STAR 102.5 KSTZ-FM you must not have won anything on STAR 102.5 KSTZ-FM in the past 30 days or any prize valued at \$600 or more in the past 6 months.
