

## **STAR TXT Sweepstakes: Post Malone & Jelly Roll**

Starting Monday, June 29<sup>th</sup>, listeners can join the STAR Text Club by texting “STAR” to 515-280-1025. Then, on Friday, July 3<sup>rd</sup> at 10:00 am, all members of the STAR Text Club will receive a message with a link to an online contest for a chance to win a pair of tickets to see Post Malone & Jelly Roll: The Big Ass Stadium Tour with special guest Carter Faith at Jack Trice Stadium in Ames on Friday, July 17<sup>th</sup>.

To participate, listeners must join the STAR Text Club before the message goes out on Friday, July 3<sup>rd</sup> at 10:00 am. Once they receive the text, members can follow the link to the contest page and complete the entry form. Entries must be submitted by Sunday, July 5<sup>th</sup> at 11:59 p.m. to qualify. The following week, four winners will be randomly selected from all eligible entries and contacted.

Listeners must have a working mobile phone with texting capabilities to enter this contest. Listeners can only enter once. Any attempt made by a listener to enter multiple times, including by using someone else’s personal information, will disqualify them. The use of software or hardware that allows a user to enter more than once per keyword is strictly prohibited. In the event of a dispute over an entry, the authorized user of the email address given at the time of winning will be declared the entrant, and that person must be eligible to win under these official rules. STAR 102.5 KSTZ-FM has the final say on who wins their contests.

By entering this contest, contestants understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. These tickets are DIGITAL and will be emailed to winners upon completion of a waiver during business hours, who must have a smartphone in order to use them at the venue. STAR 102.5 will make their best efforts to transfer tickets before the start of the event. STAR 102.5 will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station’s control. Winners are expected to follow all COVID-19 guidelines and any other rules and restrictions put forth by the event organizers and venue. These tickets have an approximate retail value of \$200.

**This contest is open to all eligible Iowa residents 18 years or older who have not won anything on STAR 102.5, nor any Des Moines Media Group Station in the last 30 days.** This period extends to six months for those who have won any prize valued at \$600 or

more. No purchase necessary. This prize has an approximate retail value of \$116. Prizes are non-transferable and cannot be exchanged, substituted or redeemed for cash. Winners must present valid state ID and w9 to collect the prize. Winners are responsible for all taxes and fees associated with the prizes.

1. No purchase is necessary to enter any STAR 102.5 KSTZ-FM contest.
2. To be eligible to win any prize on STAR 102.5 KSTZ-FM you must not have won anything on STAR 102.5 KSTZ-FM in the past 30 days or any prize valued at \$600 or more in the past 6 months.
