

STAR 102.5's Spin the Ferris Wheel Sweepstakes

“STAR 102.5's Spin the Ferris Wheel Sweepstakes” is an on-air contest running weekdays from Monday, July 27th through Friday, August 7th, giving listeners the chance to win tickets to a variety of Iowa State Fair Grandstand concerts and events.

To enter, listeners must listen for the cue to call the STAR 102.5 studio at 515-280-1025 and be caller number 10 for the chance to play. For two weeks, STAR jocks will give the cue to call twice each weekday—once during morning drive at 7:00 AM and again during afternoon drive at 4:00 PM. The 10th caller will get the chance to “spin” the STAR State Fair Ferris Wheel and instantly win tickets. With a Ferris Wheel sound effect and a little bit of suspense, wherever the wheel lands, they'll win the tickets inside that Ferris Wheel pod. There will be 20 total winners throughout the contest.

Listeners may win only once, and only one win is permitted per household. Any attempt made by a listener to win multiple times, including by using someone else's personal information, will disqualify them. The use of software or hardware that allows a user to enter more than once is strictly prohibited in all Des Moines Media Group contests. In the event of a dispute over an entry, the authorized user of the email address given at the time of winning will be declared the entrant, and that person must be eligible to win under these official rules. These tickets are PHYSICAL and will need to be picked up at the station located at 1416 Locust St. in downtown Des Moines, right across from the Papa John Sculpture Park. We are open Monday through Friday, 8 am to 5 pm. STAR 102.5 will not be held responsible if any tickets, certificates, or other prizes cannot be redeemed if an event is rescheduled or cancelled due to circumstances outside of the station's control. Winners are expected to follow all COVID-19 guidelines and any other rules and restrictions put forth by the event organizers and venue. These tickets have an approximate retail value from \$50-\$300.

By entering this contest, contestants understand and agree that any Personal Data provided during the entry process will be collected and used by Saga Communications, Inc. to identify and communicate with them. In certain circumstances, STAR 102.5 KSTZFM may share that Personal Data with sponsors, advertisers, affiliates, or other partners. This contest is open to all eligible Iowa residents 18 years or older who have not won anything on STAR 102.5, nor any Des Moines Media Group Station in the last 30 days.

This period extends to six months for those who have won any prize valued at \$600 or more. No purchase necessary. Prizes are non-transferable and cannot be exchanged, substituted or redeemed for cash. Winners must present valid state ID and w9 to collect the prize. Winners are responsible for all taxes and fees associated with the prizes.

1. No purchase is necessary to enter any STAR 102.5 KSTZ-FM contest.

2. To be eligible to win any prize on STAR 102.5 KSTZ-FM you must not have won anything on STAR 102.5 KSTZ-FM in the past 30 days or any prize valued at \$600 or more in the past 6 months. Only one winner per household is permitted within 30 days after a household has a winner. Any prize awarded to an ineligible listener will be deemed null and void, and an alternate eligible winner may be named.

3. Anytime you call the STAR 102.5 KSTZ-FM studios you assume that your call will be broadcast or recorded and you grant us permission to broadcast the call or record it for later broadcast.

Thus, all contests heard on the internet are delayed. This delay can last for as much as 30 seconds or more. This means that when STAR 102.5 KSTZ-FM contests are played that require a specific caller to telephone the radio station (such as "Caller number 9 when you hear the sound effect"), listeners to the on-line audio stream may be at a disadvantage in participating over those listeners who hear the contests on-air.
